Reasoning

"HARTMAN&MAYER" Trg Miladih bb St, building Delta II, Lamela C, first floor, Brcko district BiH submitted on 28 February 2018 the request for the issuance of the Decision on meeting the requirements for the establishment of an adult education organizer, number: 37-001162/18. The Head of the Education Department, after meeting the requirements and the necessary additions to the requirements, in accordance with Article 19 of the Law on Adult Education in the Brcko District of Bosnia and Herzegovina ("Official Gazette of the Brcko District of BiH", number: 50/18) and Article 6 and 7 of the Rulebook on the procedure for determining the meeting the requirements for the establishment of an adult education organizer ("Official Gazette of the Brcko District of Bosnia and Herzegovina", number: 12/19) appointed the Expert Commission by Act number: 37-001162/18 as of 23 April 2020, 8 June 2020 and 9 July 2020.

The Expert Commission, after conducting the procedure in accordance with the above-mentioned Rulebook, on 20 August 2020 adopted Minutes for reviewing the application and elaboration and providing expert opinion for the establishment of an adult education organizer at the request of the applicant, number: 37-001162/18, and submitted it to the Head of the Department of Education in accordance with the regulations.

In the part of the Minutes referring to item 7 of the Opinion of the Expert Commission on the meeting the requirements for the establishment of an adult education organizer, the Expert Commission determined that the Center for adult education "Hartman&Mayer" Brcko, Trg Miladih bb St (with corrections regarding the curricula and programs for economic and construction profession) meets the requirements for the establishment and implementation of the programs specified in item 2 of the enacting clause of this Decision. The applicant has been informed about the obligation to correct the mentioned curricula and programs for the economic and construction profession.

Applicant "Hartman&Mayer" Brcko, Trg Miladih bb St on 9 August 2020 submitted an amendment to the application number: UP-1-37-000066/20, in the form of a correction in accordance with the Conclusion of the Expert Commission, after which the Department started drafting this Decision.

In accordance with all the above, it was decided as in the enacting clause of this Decision.
