Pursuant to Article 22 of the Law on the Government of the Brcko District of BiH-consolidated text ("Official text of the Brcko District of BiH", number: 22/18, 49/18, 8/19, 10/19 and 32/19), and in accordance with the Article 23 of the Law on Adult Education in the Brcko District of Bosnia and Herzegovina ("Official Gazette of the Brcko District of Bosnia and Herzegovina", number: 50/18), on the proposal of the Commission for meeting the requirements for entry in the Register of adult education, appointed by Decision No.: 37-000826/20 of 17 September 2020, the Head of the Education Department of the Brcko District Government of BiH adopted

#### Decision

on meeting the requirements for entry in the Register of Adult Education Organizers

1. This Decision shall determine the fulfillment of the requirements for entry in the Register of adult education organizers, of adult education organizer "Hartman&Mayer" Trg Mladih bb St, and shall allow entry in the Register of adult education organizers.
2. After entry in the Register of adult education organizers, the adult education organizer shall also be registered in the court register and shall acquire the status of a legal entity on the day of entry.

#### Reasoning

On 11 September 2020, the Department of Education issued a Decision on the meeting the requirements for the establishment of an adult education organizer, number: 37-001162/18, by which the meeting the requirements for the establishment of an adult education organizer is determined. The decision was adopted according to the previously implemented procedure in accordance with Articles 19 to 21 of the Law on Adult Education in the Brcko District of Bosnia and Herzegovina ("Official Gazette of the

Brčko District of Bosnia and Herzegovina", number: 50/18), and the Minutes of the Expert Commission for examining application and elaboration and provision of an expert opinion for the establishment of an adult education organizer at the request of the applicant "Hartman&Mayer" Trg Mladih bb St, building Delta II, Lamela C, first floor, Brčko district BiH. In accordance with the provisions of Article 23, paragraph (3) of the Law on Adult Education, the Head of the Education Department on 17 September 2020 adopted the Decision on the appointment of the Commission for meeting the requirements for registration in the Register of adult education organizers of the applicant "Hartman&Mayer" Brčko District of BiH. In its work, as stated in Article 2 of the Decision on appointing the Commission, the Commission was guided by the Decision on meeting the requirements for the establishment of an adult education organizer, the Minutes of the Expert Commission, and the Rulebook on the procedure for determining the requirements for entry into the Register, content and manner of keeping the Register ("Official Gazette of the Brčko District of BiH", number: 12/19). In accordance with Article 23, paragraph (4) of the Law on Adult Education, the Commission drafted a Report for meeting the requirements for entry in the Register of Adult Education Organizers, namely the applicant for the establishment of an adult education organizer "Hartman&Mayer", on 23 September 2020. In the aforementioned Report, the Commission, after the procedure on meeting the requirements for entry in the Register of Adult Education Organizers, unanimously proposed to the Head of the Department to adopt a Decision on meeting the requirements for entry in the Register, in accordance with Article 23, paragraph (5) of the Law on Adult Education in the Brčko District of BiH ("Official Gazette of the Brčko District BiH", number: 50/18).

In accordance with all the above, it was decided as in the enacting clause of this Decision.

Instruction on legal remedy:

An appeal against this Decision is allowed within 15 days from the day of receipt of the Decision to the Appeals Commission, through this body.
